- 1) To vacate the unit assigned by 10AM on the final day of rental
- 2) To not occupy the unit with more persons (over 2 yrs) than is allowed in unit (as per above)
- 3) To not occupy the unit with any pets.
- 4) To accept responsibility for any loss or damages caused to unit, fixtures or inventory during stay.
- 5) To respect the rights of all other guests staying at resort. (ie. No excessive noise after 10PM)
- 6) Sublets are NOT permitted. Lead name MUST be present at check-in and checkout.
- 7) FC is not responsible for any lost or stolen valuables. Safes are available for rental.
- 8) A lost key fee of €6.00 will be applied to any lost keys (initially 2 supplied at check-in)
- 9) To abide by Community Rules & Pool Regulations posted.
- 10) To leave on deposit One Hundred Euros (€100.00) in concept of **deposit** for any damages. This will be returned at checkout. (may be left in cash or credit card slip. Can also be paid with US \$ or GB £).
